**Failure to Pay:** The parent agrees to pay the aforementioned tuition and fees as specified, time being of the essence with respect thereto. In the event of non-payment of any funds due thereunder, New World Learning Academy, LLC reserves the right to cancel this agreement and to exclude Child from participating in the instruction. The unpaid balance shall accrue thirty days from and after the due date, until paid in full at the interest rate of 1.5% per month. The annual percentage rate shall be 18% in the event that it becomes necessary for New World Learning Academy, LLC to employ a collection agency and/or an attorney for collection of any amounts due under this agreement. Parent agrees to pay all the costs and expenses incurred by New World Learning Academy, LLC. Delinquent accounts will be sent to a company or lawyer employed by NWLA for collections management. If payment is still delinquent at the end of the second month, the student’s attendance will be suspended on the 1<sup>st</sup> day of the next month. Placement is lost if balance is not brought to a current status by the 30<sup>th</sup> of that month (in February, 28<sup>th</sup>).

The parent understands and agrees that the Child’s placement is not secured until all enrollment forms and fees have been turned into the office.
